**Date of Offense**    On or about December 22, 2020

The Jurors of the Grand Jury of the State of Ohio, duly selected, impaneled, sworn and charged to inquire of crimes and offenses committed within the body of Franklin County, in the State of Ohio, upon their oath do find and present that Adam C. Coy late of said County, on or about December 22, 2020, within the County of Franklin aforesaid, in violation of section 2903.02 of the Ohio Revised Code, did cause the death of Andre Hill, as a proximate result of the offender committing or attempting to commit an offense of violence that is a felony of the first or second degree, to wit: Felonious Assault, in violation of Section 2903.11 of the Ohio Revised Code.

**Count Two**            **Felonious Assault, §2903.11, F2**  
**Defendants**            Adam C. Coy  
**Date of Offense**    On or about December 22, 2020

The Jurors of the Grand Jury of the State of Ohio, duly selected, impaneled, sworn and charged to inquire of crimes and offenses committed within the body of Franklin County, in the State of Ohio, upon their oath do find and present that Adam C. Coy late of said County, on or about December 22, 2020, within the County of Franklin aforesaid, in violation of section 2903.11 of the Ohio Revised Code, did knowingly cause serious physical harm to Andre Hill and/or did knowingly cause or attempt to cause physical harm to Andre Hill by means of a deadly weapon or dangerous ordnance, to wit: a firearm.

**Count Three**        **Dereliction Of Duty, §2921.44, M2**  
**Defendants**            Adam C. Coy  
**Date of Offense**    On or about December 22, 2020

The Jurors of the Grand Jury of the State of Ohio, duly selected, impaneled, sworn and charged to inquire of crimes and offenses committed within the body of Franklin County, in the State of Ohio, upon their oath do find and present that Adam C. Coy late of said County, on or about December 22, 2020, within the County of Franklin aforesaid, in violation of section 2921.44 of the Ohio Revised Code, did while being a law enforcement, ministerial, or judicial officer negligently fail to perform a lawful duty in a criminal case or proceeding.

**Defendants**      Adam C. Coy


